Purchaser agrees to the following:

1. This cat will never be leased, given away, or sold to any pet shop, research laboratory, or similar facility.
2. This cat will be kept indoors and will not be allowed to roam freely outside.
3. This cat is being purchased as a: PET ___ BREEDER ___.

4. If this cat is purchased as a pet, Purchaser agrees to neuter or spay this cat before the age of 5 months and agrees and guarantees that this cat will not be used as a stud or for breeding. Seller agrees to provide registration papers to Purchaser for this cat upon presentation of a licensed veterinarian's certificate of neutering or spaying.

5. This cat cannot be shown without written permission from the Seller.

6. Absolutely no cash refunds will be given under any circumstances. Deposits are also non-refundable. All shipping expenses and veterinary fees are the sole responsibility of the Purchaser.

7. If this cat is purchased as a breeder male, Purchaser agrees not to use this cat for outside stud service, except as follows:

When the Purchaser is done using this cat for breeding, he is to be neutered and not resold as a breeder. This cat is not to be leased. This cat is to be neutered before leaving the Purchaser's residence.

8. If this cat is purchased as a breeder female, no co-ownership, transfer of queen's ownership, or other devious means of circumventing this restriction will be tolerated. When the Purchaser is done using this cat for breeding, she is to be spayed and not resold as a breeder. This cat is not to be leased. This cat is to be spayed before leaving the Purchaser's residence.

9. If this cat is purchased as a breeder, Purchaser agrees to breed this cat only with other Bengals or the Asian Leopard Cat. Failure to honor this will result in forfeiture of the cat and registration papers back to the Seller.

HEALTH GUARANTEE:

This cat is guaranteed to be of sound health upon arrival. It is recommended that this cat be in quarantine for at least two weeks. Health is guaranteed for a period of 5 days (beginning on the date Purchaser receives cat) if it is vet-checked within the first 72 hours. If it is found to be medically deficient with an untreatable/life-threatening problem by a licensed veterinarian, then documentation from the veterinarian must be provided to the Seller immediately. After cat is returned to Seller, it will be replaced with another cat of comparable quality and value, as available, at the discretion of the Seller. No refunds will be given under any circumstances. All shipping expenses and veterinary fees are the sole responsibility of the Purchaser. This cat cannot be returned to Seller after the guarantee period has expired and/or if it has been exposed to a cat that has not been currently tested negative for FeLV and FIV. It is the responsibility of the Purchaser to provide immediate veterinary care to any cat showing signs of illness or distress. Failure to do so will render this health guarantee null and void. Under no circumstances is this cat to be destroyed prior to notification by the Purchaser to the Seller. If a cat dies within the guarantee period, despite medical treatment, a replacement will be given only upon examination and verification of cause of death from a licensed veterinarian and after a veterinary death certificate is provided to Seller. All veterinary fees are the sole responsibility of the Purchaser.

This cat is guaranteed against internal congenital defects for 6 months (beginning on the date Purchaser receives cat). The internal congenital defect guarantee does not include cosmetic defects (i.e. lockets and tail faults). Should the cat die within that time as a direct result of an internal congenital defect, the cat will be replaced only if an appropriate necropsy is performed by a licensed veterinarian and after a veterinary death certificate is provided to Seller indicating the presence of an internal congenital defect. Additionally, this cat is guaranteed against Feline Hypertrophic Cardiomyopathy (HCM) for 12 months (beginning on the date Purchaser receives cat). Seller's veterinarian must confirm that the cat is HCM positive before a replacement will be given to the Purchaser. Upon confirmation of an internal congenital defect or HCM, it will be replaced with another cat of comparable quality and value, as available, at the discretion of the Seller. No refunds will be given under any circumstances. All shipping expenses and veterinary fees are the sole responsibility of the Purchaser. Due to the many factors involved in rearing and caring for this cat that are beyond the control of the Seller, there are no guarantees on fertility or temperament.

If purchased as a breeder, this cat is guaranteed to be free of tail faults and lockets upon arrival. Specifically, if a tail fault or locket is present at the time of arrival, Purchaser must notify the Seller within 24 hours of receiving it. After cat is returned to Seller, it will be replaced with another cat of comparable quality and value, as available, at the discretion of the Seller. Seller must confirm the presence of a tail fault or locket before a replacement will be given. No refunds will be given under any circumstances. All shipping expenses are the sole responsibility of the Purchaser. There is absolutely no guarantee against the eventual development of a tail fault, locket, or other cosmetic defect.

If this cat is resold to another individual, this contract is null and void. The Purchaser agrees to the terms and conditions set forth in this contract. In the event of default, the Purchaser will be legally liable for any reasonable attorney fee and/or collection fee and all related costs necessary to uphold this contract.
